Exception: If the end of the regular season and the start of the post-season tournament are separated by three days or more, the tournament brackets will be set up based on the league standings at the end of the regular season.

Brackets with seed numbers will be posted on FSCBL website at least 2 weeks prior to end of season. Brackets will be re-posted with team numbers once final standings and seeding is completed. Ties in seeding will be broken by head-to-head records first and then by team numbers (which are randomly drawn during team declaration in March).
